**ORDINANCE**  
**(No. 5 of 2017)**

Whereas the Government of India in the Department of Agricultural Research and Education (Indian Council of Agricultural Research) on the basis of recommendation of the 1st meeting of the Academic Council held on 08.07.2017 and resolution passed in the 2<sup>nd</sup> meeting of the Board of Management of the University held on 14.07.2017 has approved to make an Ordinance regulating the award of Fellowship to the students of Dr. Rajendra Prasad Central Agricultural University, Pusa F.No. 5-50/2017-CAU dated 12<sup>th</sup> September 2017.

Now, therefore, in exercise of the powers conferred by clause (f) of sub-section (1) of section 28 of the Dr. Rajendra Central Central Agricultural University Act, 2016 (32 of 2016), and with the previous approval of the Central Government, as aforesaid, I, the Vice-Chancellor of the Dr. Rajendra Prasad Central Agricultural University, Pusa do hereby make this Ordinance and notify that the student who are not recipient of any kind of financial assistance from any source and maintained OGPA of 7.5 and above in PG and Doctoral programme shall be allowed fellowship as per existing rate i.e. Rs. 3000/- p.m. for Masters programme and Rs. 4500/- for Doctoral degree programme. This provision will be valid only for such students already admitted in the University. However, for fresh students the matter should be put to Finance Committee.
