ORDINANCE
(No. 6 of 2017)

Whereas the Government of India in the Department of Agricultural Research and Education/Indian Council of Agricultural Research on the basis of recommendation of the 1st meeting of the Academic Council held on 08.07.2017 and resolution passed in the 2nd meeting of the Board of Management of the University held on 14.07.2017 has approved to make an ordinance regarding the conduct of examination, including the term of office and manner of appointment and duties of examining bodies, examiners and moderators of the students of the Dr. Rajendra Prasad Central Agricultural University, Pusa F.No. 5-50/2017-CAU dated 12th September 2017.

Now, therefore, in exercise of the powers conferred by sub-section (2) read with clause (g) of sub-section (1) of Section 28 of the Dr. Rajendra Prasad Central Agricultural University Act, 2016 (32 of 2016) and with the previous approval of the Central Government, as aforesaid, I, the Vice-Chancellor of the Dr. Rajendra Prasad Central Agricultural University, Pusa, do hereby make this Ordinance and notify the condition and procedure for conduct of semester system of examination for Under-graduate, Post-Graduate and Doctoral Programme of the Dr. Rajendra Prasad Central Agricultural University, Pusa as per existing Academic Regulations of the University till further notification.
