**ORDINANCE**  
**(No. 2 of 2017)**

Whereas the Government of India in the Department of Agricultural Research and Education/Indian Council of Agricultural Research on the basis of recommendation of the 1st meeting of the Academic Council held on 08.07.2017 and resolution passed in the 2<sup>nd</sup> meeting of the Board of Management of the University held on 14.07.2017 has approved to make an ordinance regarding the Course of Study in the Dr. Rajendra Prasad Central Agricultural University, Pusa vide F.No. 5-50/2017-CAU dated 12<sup>th</sup> September 2017.

Now, therefore, in exercise of the powers conferred by the clause (b) of Sub Section (1) of Section 28 of the Dr. Rajendra Prasad Central Agricultural University Act, 2016 (32 of 2016) and with the previous approval of the Central Government as aforesaid, I, the Vice-Chancellor of the Dr. Rajendra Prasad Central Agricultural University, Pusa, do hereby make this Ordinance and notify that the Courses of Study for different under-graduate programmes at DRPCA shall be as prescribed by the Vth Deans Committee of the Indian Council of Agricultural Research or as revised from time to time.

For PG & Doctoral degree programme the course of Study based on Common Academic Regulation 2010 of ICAR will continue.
