Dr. Rajendra Prasad Central Agricultural University, Pusa is advertising one (01) post of Project Associate-I, purely on contractual basis and time bound nature under DBT Funded Research Project entitled "Introgression of QTL(s) for increasing grain Dimethylarsenic acid (DMA) concentration in mega varieties of rice" in the Deptt. of AB&MB, CBS&H, RPCAU, Pusa.

**Eligible candidates may attend the walk-in-interview on 04.09.2024 at 09:00 AM at Office Chamber of Dean, CBS&H, RPCAU, Pusa, Samastipur.** The candidates should bring the print out of their application duly filled in the prescribed proforma (Attached) along with original and self-attested copies of all necessary documents related to date of birth, educational qualifications, experience certificate etc.

Applicants should report positively before half an hour to the prescribed time at **the said venue.**

#### **Terms & Conditions**

1. Above position is purely temporary and will be filled on contractual basis with co-terminus with the project. The post will be offered initially for a period of one year or till termination of the project whichever is earlier and further extendable based on periodic review and satisfactory performance for the remaining period of the project.

2. The University reserves the right to increase/ decrease the number of post/alter any conditions at any point of time or not to fill up any of the posts advertised in case of non-availability of any suitable candidate or due to any other reasons without adducing any reason thereof.
3. Further, this post is governed strictly by the relevant rules/regulations/conditions of service framed by the DBT and the RPCAU, Pusa from time to time.
4. No TA/DA will be borne by the University to attend the interview.
5. Canvassing in any form will lead to disqualification and if shortlisted, the candidate will not be interviewed by the Selection Committee.
6. Selected candidates will not be entitled to claim for regular appointments/absorption either in the University. Non-maintenance of the discipline and failure to perform the assigned duties will make the selected candidate liable for termination during the appointment period as per rules.
7. No Objection Certificate from the employer shall be produced in case the candidate is employed elsewhere.
8. Candidates will be shortlisted for Interview on the basis of their academic qualification, experience, publication, achievements/awards etc. submitted by the candidates with the duly filled application form and considering relevant criteria as per job requirement of the position. **Only the shortlisted candidates after screening procedure will be allowed to appear in the interview.**
9. Candidate fulfilling the essential Qualifications and eligibilities criteria only need to apply for this post. The self-attested document furnished by the selected candidate (s) with his/her application form shall be verified from original documents. It is mandatory to produce the documents in front of Committee, any relaxation in this regard will not be accepted.
10. If the interview is not conducted as scheduled due to any unavoidable circumstances, then you may have to stay for next day for interview, without any TA/DA claim.
11. Candidates ***are also requested to bring 05 copies of your updated duly signed short CV (not more than 02 pages) at the time of interview.***
12. Failing to comply on above points, candidate may be debarred from interview.
13. Canvassing in any form or bringing any influence will be treated as disqualification.
14. In case of any disputes, it will be resolved in the jurisdiction of Patna High Court only.
15. Candidates are advised to fill their application form carefully such as Name, Father's name, Date of Birth, Category, Qualification, e-mail & mobile number and other details, it is mandatory to enclose/attach essential documents along with recent two (2) passport size photo (not more than 06-month-old) & Signature. Candidate will be responsible for any mistake in the data of application form and no correspondence will be entertained in this regard.
16. All the relevant columns of the application form should be filled in.
17. Candidate is required to clearly mention the post name on the application form. Failing to the same, his/her candidature will not be considered & candidate would be solely responsible for that.
