**ADMISSIONS TO UNDERGRADUATE DEGREE PROGRAMMES (2024-25) OF THE
UNIVERSITY THROUGH MOP-UP ROUND**

Applications are invited for admission in the vacant seats in various undergraduate programmes for the Academic Session 2024-25 at Dr. Rajendra Prasad Central Agricultural University, Pusa. Aspirants for Undergraduate programmes for all the disciplines for the Academic Session 2024-25 are advised to apply with one to three choices, as applicable, of subjects, using the link: <http://rpcauonline.in/> (which will be opened from 1st November 2024) provided on the University website (www.rpcau.ac.in) till **05.11.2024** (11:59 pm). The counseling process will take over as per timeline given below.

The admission will be in the same category which is mentioned on the seat vacancy matrix, depending on vacant seats/leftover seats available after admission rounds from ICAR admission process. The candidates applying for seat in mop-up round for UG are instructed to apply only in the relevant degree programme as per the vacancy seat matrix. Those aspirants who have not appeared in ICAR examination (ICAR CUET-2024) need not to apply, and if applied their candidature will be rejected and cancelled.

The following Processing Fee will be charged for the mop-up round which is nonrefundable and nonadjustable.

Terms and conditions for RPCAU Mop-up round

1. Only the candidates/ applicants who secured the ICAR scores and ranks are eligible to participate.
2. The required qualifications for any degree programme for RPCAU Mop-up round remain same as that of the ICAR counseling.
3. The Processing fee are nonrefundable and nonadjustable under any circumstances by the University. Hence, candidates/ applicants are advised to be careful on this account.
4. Those candidates who scored zero or negative marks in the CUET (ICAR-UG)-2024 conducted by NTA are not allowed to participate in the mop-up/final round of counseling.
5. The candidates who already stand admitted through ICAR Counseling in RPCAU or any other university/ institute are not allowed to participate in the Mop-up round counseling.
6. The candidates who will be admitted through RPCAU Mop up round will not be offered any kind of scholarship/ fellowship from ICAR/ University.
