Five (05) years experience of handling court cases of University /Government departments or offices of State/Central Government.	1. To facilitate the Advocates in preparation of drafts of counter affidavits as well as to assist the office in seeking legal opinion on different issues as desired by the authorities/officers. 2. To execute affidavits in different legal cases. 3. To facilitate the units of the university and officers in execution of Memorandum of Understanding (MoU) by way of legal vetting of proposed drafts. 4. To manage the court cases pending in different courts. 5. To advice the offices in different matters for their smooth functioning. 6. Develop mechanism for reduction in court cases. 7. To execute all the works as assigned by the Competent Authority from time to time.
