ADMISSIONS TO UNDERGRADUATE/POSTGRADUATE/ DOCTORAL DEGREE PROGRAMMES (2025-26) AGAINST VACANT SEATS OF THE UNIVERSITY THROUGH RPCAU MOP-UP ROUND

Applications are invited for admission in the vacant seats in various UG, PG, and PhD for the Academic Session 2025-26 at Dr. Rajendra Prasad Central Agricultural University, Pusa. Candidates applying for the vacant seats in the RPCAU Mop-up round for UG, PG, and PhD are instructed to apply only to the relevant degree programme as per the vacant seat matrix (<https://icarcounseling.com/Home> or www.rpcau.ac.in). The number of seats may be increased as per actual availability at the time of admission. Choice filling for applicants will be as follows: UG – 5 choices; PG – 3 choices; PhD – 1 choice, as applicable, of subjects, using the link: www.rpcau.ac.in (which will be opened from 4th December 2025 (10:00 AM) till 6th December 2025 (05:00 PM)).

The following processing fee will be charged for the RPCAU Mop-up round which is nonrefundable and nonadjustable.

Terms and conditions for RPCAU Mop-up round

1. Candidate who had applied for ICAR Mop-up round will only be considered for RPCAU Mop-up round.
2. The candidates who already admitted/ provisionally allotted/ accepted seat through ICAR Counselling in RPCAU or another university/institute are not allowed to participate in the RPCAU Mop-up round Counselling.
3. The required qualification for any degree programme for RPCAU Mop-up round remains same as that of the ICAR Counselling/university norms.
4. The processing fee is non-refundable and non-adjustable under any circumstances by the university. Hence, Candidates/ applicants are advised to be careful on this account.
5. Those candidates who scored zero or negative marks in the ICAR examination (ICAR CUET- UG, AIEEA (PG) and AICE-JRF/SRF (PhD) 2025-26 are not allowed to participate in the RPCAU Mop-up round.
6. The Candidates who will be admitted through RPCAU Mop-up round will not be offered any kind of Scholarship/fellowships from ICAR/University.
7. Submission of incorrect information will lead to cancellation of seat, without refund at any stage.
